

Sir/Madam,

This is in continuation of the Notification No. F. 23-5-7/2015/NIOS/SSS/5520 dated 1st October, 2015 (235/2015) and the subsequent reminder of even no. dated 29.12.2015. The NIOS is receiving reserved fund from some of the AIs/AVIs/AAs at Regional Centres as well as at NIOS, Headquarters. It is clarified that the reserved fund is required to be kept at the concerned AIs/AVIs/AAs as a fixed deposit in the name of the concerned AIs/AVIs/AAs duly pledged in the name of Secretary, NIOS. However, the detailed Guidelines for reserved fund are being issued separately. All the Regional Directors are directed to inform all AIs/AVIs/AAs accordingly.

It may also be noted that as mentioned in the letter dated 29.12.2015, all the AIs/AVIs/AAs who have completed five years as on 1st October, 2015 are required to pay the renewal of accreditation fees of Rs.15,000/- to the concerned Regional Centre without any further delay.
