**Subject : Renewal of Accreditation of AIs/AVIs/AAs and Extension thereof.**

Sir/Madam,

This is in continuation of the Notification F-23-5-7/2015/NIOS/SSS/5520 dated 1<sup>st</sup> October, 2015 (Notification 235/2015) and subsequent letter of even number dated 29<sup>th</sup> December, 2015 and 4<sup>th</sup> Feb. 2016 on the subject cited above. The last date for receipt of Renewal of Accreditation fee was extended up to 29<sup>th</sup> February 2016. It has however, been observed that large number of AIs/AVIs/AAs have yet to deposit the accreditation fee for renewal of accreditation.


Reference is also invited to the Notification No. 235/2015 dated 1<sup>st</sup> October 2015 wherein all the study centres (AIs/AVIs/AAs) have been informed to go in for extension of accreditation incase the respective AI/AVI/AA **has completed 05 years of accreditation period as on 30<sup>th</sup> September 2015.** All AIs/AVIs/AAs who have completed 05 years accreditation with NIOS have to apply for extension of accreditation with the revised prescribed fee. It has now been decided to accept the renewal accreditation fee of Rs.15000/- to the concerned Regional Centres by **30<sup>th</sup> June, 2016.**

The Regional Directors should ensure that the fee for extension of accreditation has to be received within the stipulated time limit and the same intimated to NIOS Headquarters. Instances have come to the notice that some of the AIs/AVIs/AAs (Independent schools) are non-functional, the details of the same is also required to be forwarded to the Headquarters so as to take appropriate action for dis-accreditation of such of the AIs/AVIs/AAs (independent schools).

In the event of non-compliance of receipt of fees for extension of accreditation, the admission of the concerned AIs/AVIs/AAs would be stopped. All the AIs/AVIs/AAs be directed of the same. This may also be uploaded on Regional Centre's website.

This may be treated as 'MOST URGENT'.
